1.0 INTRODUCTION

i. M/s Hindustan Petroleum Corporation Limited (HPCL), a Maharatna Public Sector Undertaking, involved in Refining, Marketing and Distribution of Petroleum products has established a world class Research & Development (R&D) Centre with State of the Art Research & Development facilities at Bengaluru.

- ii. HPCL has its 'Green R&D Centre' with State of the Art Research & Development facilities at Devangonthi, Bengaluru. R&D facilities are designed with the highest level of safety and energy efficient features to meet the current and long term Research and Development needs of the corporation. It is built in a campus of about 110 acres incorporating several green and sustainable features. The design and the construction has been done meeting the GRIHA (Green Rating for Integrated Habitat Assessment) administered by TERI and also LEED (Leadership in Energy and Environmental Design) by IGBC
